DSNY requires cardboard to be flattened and bundled securely. Leaving loose boxes on the curb is a citation magnet. In high-volume environments, many buildings utilise cardboard balers to compress this material into manageable blocks.

They are responsible for breaking down hundreds of boxes a night, removing packing tape and Styrofoam peanuts, and feeding the baler. This is labour-intensive work that requires safety training and diligence. ## **E-Waste and Universal Waste Protocols**

These items require special handling and must be diverted to specific recycling facilities.
